## व्यसनमुक्ती मुक्तांगणी आज बैठक

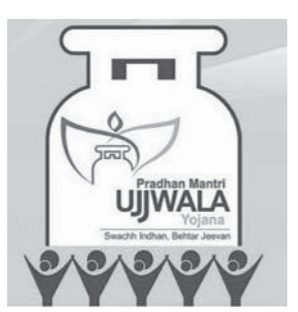
